TERMS AND CONDITIONS OF TENDER

1. Both Technical and financial tenders will be accepted separately. Tenders will be processed and accepted through E- Procurement system as prescribed by GOR.
2. Tenders are invited to submit online E-tender, which shall contain the information about the tenderer eg. experience & past performance in the execution of similar contract (S), capability with respect to personnel, equipments, financial status, capacities, price quotations along with offer rates in given format.
3. Demand Drafts of EMD (EMD exempted Govt./ Govt. undertaking or Govt. institution) and tender fee in favor of RSSCL and fee of RISL, in favour of Managing Director, RISL as mentioned in the e. tender shall be submitted, physically at RSSCL Jaipur before time of technical bid opening. Scanned copies of above Demand Drafts shall also be submitted online with technical bid.
4. The Supplier will be responsible for the supply of foundation seed of varieties mentioned in tender form and quantities thereof as agreed, and will make available the foundation seed of those varieties as shall be mentioned in the agreement which should be certified by the authorized Seed Certification Agency.
5. The guarantee of physical purity, genetic purity and germination would be given by the tenderer. In case of any complaint, the tenderer would be responsible for making good the losses to the farmers and / or the Company (RSSCL). In case of foundation seed the copies of STL report with section- IX certificate and STL report as mentioned in the offer will also be submitted to RSSC along with consignment.
6. The offered seed should meet the standards of IMSCS and should be treated with standard and prescribed chemical. If offered seeds are not treated at the time of packing, a packet containing sufficient quantity of chemical as per recommended dose shall be kept inside each seed packet to enable the farmers to treat the seeds before sowing. A pamphlet in Hindi giving warning about chemical and procedure to treat the seed should be kept inside seed packet along with sachet. Failure in compliance of this clause is punishable up to 25% reduction from payment bill of producer / organizer. Even if one bag is found to be not treated or kept without the specified chemical in the seed container, entire lot supplied will be considered as untreated for penalty purpose.

7. The performance security in the form of demand draft, equal to 5% of the total amount of the contract shall have to be furnished at the time of signing of the contract by the tenderer. EMD deposited shall be adjusted in this value. The Security deposit shall be refunded only after satisfactory completion of successful supply and expiry of contract tenure.
8. The supplier will be responsible for quality and completion of all the requirements in regard to finally making available the foundation seed to RSSCL.
9. The tenderer shall not change the committed quantities and committed varieties of Seed. RSSC has right to decrease the quantity as per requirement and to increase the quantity within the rules.
10. Successful bidder will be expected to supply the ordered seed on or before agreed cutoff date to concern RSSC units/ destination In Rajasthan given in the supply order. No Supply would be made after the agreed cut off dates mentioned in the agreement. For the supply after cut of date, extension in cutoff date will be obtained in writing from RSSC before expiry of cutoff date. However the supply after cutoff date, penalty 0.50% + GST for per day of delay will be imposed.
11. The tenderer should be the original seed producer or his duly authorized agent having valid seed license. The original seed producer or his authorized agent can (only after producing authorization letter from the principal on 500/- Rs. Non judicial stamp) participate in the tender process.
12. Tenderer should produce an affidavit on Rs. 100/- Non Judicial stamp paper stating that he has not been black listed in last 10 years by any institution of seed business.
13. If the tenderer fails to supply the complete quantity of seeds within the time period specified, RSSC shall be entitled to Impose a penalty of up to 5% + GST on the Producer / organizer for the unsupplied quantity.
15. The Clause nos. 11 and 14 shall not be applicable in case tenderer proves to RSSC beyond doubt for the area and quantity agreed to RSSC that, it had suffered due to natural calamities like flood/ Heavy Rainfall, cyclone, earthquake etc. with authentic proof. The extent to which the penalties applicable at clause nos. 11 and 14 shall be waived as above will be the sole discretion of RSSC.
16. The lowest rate of bidder will be accepted but order quantity may be split amongst two or more eligible tenderers if they agree or give consent to supply on lowest rate which is approved.

17. The supplier shall be responsible for dispatch of the goods to FOR destination (RSSCL unit or other stations in Rajasthan State) as communicated by RSSC before dispatch.
18. The both kinds of rates quoted shall be inclusive of all taxes whatever being levied by the Central or State Government including octroi, GST, market taxes etc., in the concerned State and Rajasthan, or in transit.
19. The supplier will supply the seed only in required Packing size certified by the concern seed certification agency.
20. The details of lot numbers of the seed along with the STL report, section 9 certificate and G.R. Way bill etc will be dispatched by tenderer to the specified destination point as specified by RSSC.
21. . RSSC head office at Jaipur shall release 70 % payment for goods received within a month's time subjected to receipt of original bills dully stock entry, I.U.T., STL report, Section-IX certificate and other necessary documents from receiving units subjected to fulfillment of the specified Terms & Conditions and balance 30 % payment will be released after receiving satisfactory report from fields including STL report. For this purpose samples shall be drawn lot wise by RSSC. As per RSSC sale rates payment of entire lots quantity supplied but failed in sample test of STL shall not be made by RSSC and no claim for this shall be entertained.
22. If there is a dispute arises between parties or the bidder is aggrieved by the action of RSSC, he may file an appeal in the prescribed Performa and manner given in RTPP act of Govt. of Rajasthan. The first appellate authority will be Principal Secretary of Agriculture Administrative Department (Department of Agriculture) and second appellate authority will be Finance Department, Govt. of Rajasthan.
23. RSSC has right to accept or reject the tender partly or fully without assigning any reason what so ever.
24. The courts of law situated at Jaipur only shall have the Jurisdiction to entertain the litigation arising out of this tender for the supply of the above seeds.
25. The Tenderer should clearly write on the envelope, "tender form for seeds Production 2017-18" The envelope should contain tender form enclosed with all required documents and demand draft of EMD.
26. The rates received in the tender shall be valid for 90 days and on acceptance of the offer shall remain valid till the expiry of the contract / supply.
