CORRIGENDUM

All interested bidders who wants to offer for more than one variety in tender No. 2458 Dated 18.05.2020 are advised to follow the filling of from as being advised below :-

(A) **Technical Bid**- All Bidders are advised to mention clearly the name of variety being offered, its quantity being offered along with its year of notifications, class of seed, treatment chemical's name and name of certification agency (if Certified Seed is being offered)

(B) **Financial Bid** - Since in the format of the E-procurement site the BOQ of Financial Bid is fixed and only two columns can be filled by a bidder which are namely (a) Name of bidder, Bidding firm/Company (b) Rate per Qtl. (Inclusive of all taxes except GST) Column no. 7. The column for rate ie- column no 7 will accept only one rate. In this situation, the interested bidders who want to offer more than one variety, are advised to give variety wise offerd qunantity in Qtls and per Qtl. rate in a bracket in the column of name of Bidder, Bidding Firm/Company after filling their name and location. *The rate to be filled in the column for Rate per Qtl. should be of the lowest rate of all the varieties being offered by that bidder.* For example if a bidder XYZ Ltd, C-Scheme, Jaipur wants to offers three varieties, ABC, DEF and GHI with respective qunantity of 5000 Qtls, 6000 Qtls, 7000 Qtls and rates of Rs. 12000, Rs. 14000 and Rs.16000 per Qtl. this bidder is advised to fill the Financial Bid as below :-
